Annexure A (Declarations of the Health Leadership Conference for MSs/CEOs/EDs):

S.No.	Declaration
1	All MSs are hereby directed to immediately initiate the registration process and submit a progress report within Hospital Registration with the Healthcare Commission within 15 days positively .
2	You have been trained on the medicine digitisation software today and now MSD will start medicine deliveries to your hospitals. Ensure all medicine stocks are entered on the DHIS dashboard and a digital record is kept.
3	The department has already delegated the power of centralized appointments to Divisional Recruitment Committees and DHCs. MSs are hereby directed to share vacant positions with Divisional Director, Divisional Commissioners for the appointment of missing HR within 15 days positively under intimation to Health Department .
4	All MSs are directed to ensure uninterrupted data sharing in DHIS2 system henceforth positively, taking preparation time of not more than a week .
5	All MSs are directed to reconcile all HR data shared in the HRMIS portal within a week positively and intimate the Health Department instantly in case of any technical or administrative issue .
6	A committee headed by the Additional Secretary (Dev-II) shall be notified to resolve issues related to the AI Frame Attendance Portal . MSs are directed to notify their focal points within a week positively . All MSs are to download the app regarding attendance and regularly update their activities in the app.
7	MSs are to notify focal persons responsible for sharing updates and content for the official website henceforth positively .
8	All hospitals shall have their own Social Media platforms and shall be linked to the departmental website henceforth positively .
9	The Health Card Desk shall be made functional , and daily progress reports are to be shared with the Health Department.
10	All MSs are hereby directed to ensure strict adherence to the protocols notified by the Health Department regarding ARVs and ASVs.
