### INVITATION OF QUOTATION-BASED PROCUREMENTS

Sealed bids are invited from well-reputed and registered firms, medical stores, and suppliers involved in the business of medicines and consumable/disposable items for cardiac surgery department. Eligible bidders must be registered with relevant departments for the **Framework Contract** supply of medicines and consumable/disposable items for cardiac surgery under the Balochistan Health Card Program (BHCP) for the year 2025-26.

The procurement process shall be conducted in accordance with the **BHCP Policy Guidelines 2024**, issued by the Health Department, Government of Balochistan.

#### **1. Eligibility Criteria:**

- a. The firm must be registered with the Income Tax Department and listed as an Active Taxpayer with the Federal Board of Revenue (FBR).
- b. The firm/company must hold a valid sales tax registration with the FBR and must possess a license/registration from the Health Department or other relevant authorities for providing such supplies.
- c. The bidder must have Financial Capacity/worthiness of Rs. 10 Million. The bidder must submit Turn Over Certificate of bidder's bank account.
- d. The bidder must have renewed DRAP License.
- e. All supplied items must be registered by Drug Regulatory Authority of Pakistan (DRAP).
- f. The shelf life must be 75-80% from the date of supply of medicines and consumables items for local and imported items.
- g. The list of required medicines, surgical, and consumable items can be obtained from the office of the undersigned during official timings.
- h. Declaration on Affidavit duly signed by Notary Public/Oath Commissioner on **Rs.100/-** Stamp Paper declaring that their firm is currently non- Blacklisted or Penalized for any Default or any delivery to Govt./non-Govt. Institutions through-out Pakistan must be attached.
- i. The bidder Must have Office in Quetta City, Attach latest Paid Utility Bills along-with Tenancy Agreement or Ownership Agreement.
- j. A single-stage, one-envelope procedure will be used for quotation's opening.
- k. The financial quotation must include the maximum possible discounts on the Market Retail Price (MRP).
- l. Approval after final comparative assessment, the final work order will be granted by designated procurement committee of the hospital for BHCP.
- m. An undertaking certificate on Rs: 100/- Judicial Stamp Paper agreeing to the terms and conditions of the bidding process must be submitted.
- n. **Mode of Payment:** Payments will be made within **120 days** of supply completion, subject to completion of all required official/financial documentations and processes.
- o. All payments will be made via bank transfer to the firm's valid account.
- p. The undersigned has the authority to cancel the procurement process at any stage or extend the date of quotation submission.


#### **2. Submission Deadline:**

Sealed Quotations must be submitted by **Saturday, 9<sup>th</sup> August 2025**, no later than **12:00 PM**, at the office of the undersigned.

#### **3. Quotation Opening:**

All submitted quotations will be opened on **09-08-2025** at **01:00 PM** in the presence of the Hospital Procurement Committee at office of the Medical Superintendent Sandman Provincial Hospital, Quetta.
